Mike Runyan is a Fellow of the American College of Trial Lawyers and an Associate of the American Board of Trial Advocates. During his 33 year practice at Lane Powell, he has tried more than 50 jury cases. In 2010, he received both the Washington Defense Lawyer President's Award and the American Board of Trial Advocate's "Trial Lawyer of the Year" award.

Mike's practice includes defense of professional malpractice, product liability, and insurance/bad faith coverage litigation. He has written and lectured extensively on product liability, trial tactics, tort reform, evidence, civil procedure, electronic discovery, legal ethics and insurance bad faith. In 2000-2010, he was selected as a "Washington Super Lawyer" by his peers through *Super Lawyers* magazine and has been named one of the top 100 Super Lawyers. In July of 2001, he was awarded the Jack P. Scholfield Outstanding Achievement Award by the Washington Defense Trial Lawyers in recognition of his "outstanding loyalty, leadership, commitment and support of the goals and objectives of the civil defense trial bar." In October, 2002, WDTL members voted him "Outstanding Defense Trial Lawyer." In 2009, he became editor-in-chief of WSBA Civil Procedure Handbook.
